### EXPLANATION OF SERVICES

## TRAINING AGREEMENT

Knock Out Dog Training, LLC (hereinafter referred to as K.O. Dog Training), the individual that owns and presents for training the dog for training with/by K.O. Dog Training shall be referred to hereinafter as "Client" and the animal presented for training shall be referred to herein after as "Dog".

**Client's Duty to Assist in Continued Training:** Client is responsible for the outcome of their dog. Client understands that following the instructions as directed by K.O. Dog Training will produce optimum results. Client will read any literature provided by K.O. Dog Training regarding the training instructions and/or the tools utilized for training. Gross deviation from instruction by client nullifies the responsibilities of K.O. Dog Training in the execution of this Agreement. Maintenance of training by Client will be required to some degree for the duration of Dog's life.

**Aggression:** I understand that my dog is

I understand there are no guarantees in regard to solving this behavior problem. I agree to muzzle my dog as directed and to keep my dog out of potential problem situations at all times.

**Client's Liability:** If Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to K.O. Dog Training's Trainer and his agents and employees), during or after the term of this Agreement, on or off K.O. Dog Training's premises, then Client agrees to pay all resulting losses and damages suffered or incurred by K.O. Dog Training and his agents and employees, and to defend and indemnify K.O. Dog Training and his agents and employees from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney's fees.

Client agrees to care for anyone that he brings onto K.O. Dog Training's premises (including Client's spouse, adult friends, and the parents of non-related children) to execute a copy of the Waiver and Release for Entry to Premises which will be made available by K.O. Dog Training; as a remedy if Client breaches the foregoing provision, Client will defend and indemnify K.O. Dog Training and his agents and employees against any claims, demands, lawsuits, losses, costs or expenses, including attorney's fees, brought by or on behalf of any such persons.

**Client's Assumption of Risk:** Client acknowledges that the premises of, and the animals, guests, items and activities thereon, pose dangers to people and animals. Such dangers include, by way of example and not limitation, animals that can bite, trip, knock down, and fight, indoor and outdoor surfaces that may be slippery, equipment that can trip, guests and clients who cannot control their dogs, and activities involving Dog and/or other dogs that can result in injury from bites or other causes. Accordingly, Client, on behalf of him/her, his/her spouse and minor children, and anyone else whom Client brings onto said premises, assumes the risk of injuries, losses, damages, costs and expenses by any means above described, and other injuries, losses, damages, costs and expenses of every possible cause and description unless inflicted intentionally or recklessly by the agents and employees of K.O. Dog Training. If Dog is injured in a dog fight or an accident, gets fleas, ticks or worms, contracts any illness or disease, is lost or stolen, becomes pregnant, or engages in any dangerous, vicious or unwanted behavior, during or after the term of this Agreement, on or off said premises, Client accepts the risk of the same and agrees that K.O. Dog Training or it's agents shall not be held responsible for it or any resulting injuries, losses, damages, costs or expenses.

**Termination:** At K.O. Dog Training's sole election, K.O. Dog Training's duties hereunder shall terminate if (a) in K.O. Dog Training's sole judgment Dog is dangerous or vicious to agents of K.O. Dog Training or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, K.O. Dog Training's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect. If termination occurs within the first week of training or lessons, Client shall be entitled to a full refund less Twenty Percent (20%).

**Legal Provisions:** This Agreement is binding upon Client, the spouse of Client, and the children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that K.O. Dog Training has not represented, promised, guaranteed or warranted that Dog can be trained, that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and K.O. Dog Training. Any remedy provided in this Agreement is in addition to any and all other remedies provided by law or equity. If any provision of this Agreement is invalid, void or unenforceable, they will be severed and the remaining provisions shall be given full force and effect.

**Conclusion:** In signing on the obverse, I/we acknowledge that the above statements are true and have been thoroughly explained by K.O. Dog Training staff. I/we understand the intent of services provided by K.O. Dog Training and that attendance is not without risk to my dog or me while participating in group sessions or on the premises, and that even with great care taken in monitoring interactions, injuries can happen. I/we hereby declare that my dog(s) has not been exposed to distemper, rabies, kennel cough, parvo or other known contagious diseases within the last 60 days and that my dog(s) is free of worms, heartworm and fleas. I/we hereby agree to absolve and hold harmless any and all parties connected with the services being provided in any way, singly or collectively, from and against any blame and liability for any injury, misadventure, harm, loss, inconvenience, or damage hereby suffered or sustained as a result of participation in any services or activities therewith or while on premises or surrounding area. In the event emergency treatment for illness or injury is necessary, I/we hereby consent to and permit and assume all financial obligations resulting therefrom and agree to pay said obligations along with the costs incurred for services rendered. This release shall remain in effect until nullified in writing.
